1. Audited financial statements together with the reports of the Directors and Auditors for the financial year ended 31 March 2015

The Chairman invited questions with regards to the audited financial statements together with the reports of the Directors and Auditors for the financial year ended 31 March 2015 from the floor. After answering several questions from the floor, the audited financial statements together with the reports of the Directors and Auditors for the financial year ended 31 March 2015 were tabled and received by the shareholders.

2. ORDINARY RESOLUTION 1

- **Payment of a first and final single-tier dividend of 3% (3 sen net per ordinary share) for the financial year ended 31 March 2015**

At the proposal of Mr. Ng Yau Siong and seconded by Mr. Tee Cheong Yoke, the resolution in respect of the payment of a first and final single-tier dividend of 3% (3 sen net per ordinary share) for the financial year ended 31 March 2015 was put to vote by show of hands and was unanimously approved by the Meeting.

3. ORDINARY RESOLUTION 2

- **Payment of Directors' fees of RM340,000.00 for the financial year ended 31 March 2015**

At the proposal of Mr. Boo Kim Kee and seconded by Ms. Crissy Lee Pooi Ling, the resolution in respect of the payment of Directors' fees of RM340,000.00 for the financial year ended 31 March 2015 was put to vote by show of hands and was unanimously approved by the Meeting.

4. ORDINARY RESOLUTION 3

- **Re-appointment of Datuk Lai Siew Wah as a Director of the Company who retires pursuant to Section 129 of the Companies Act, 1965**

At the proposal of Mr. Lau Yew Mun and seconded by Mr. Thomas Wong Yoke Luen, the above resolution was put to vote by show of hands. The members present unanimously resolved to approve the re-appointment of Datuk Lai Siew Wah as a Director of the Company who retired pursuant to Section 129 of the Companies Act, 1965 and to hold office until the next Annual General Meeting.

5. ORDINARY RESOLUTION 4

- **Re-appointment of Datuk Lai Jaat Kong @ Lai Foot Kong as a Director of the Company who retires pursuant to Section 129 of the Companies Act, 1965**

At the proposal of Mr. Thomas Wong Yoke Luen and seconded by Mr. Lau Yew Mun, the above resolution was put to vote by show of hands. The members present unanimously resolved to approve the re-appointment of Datuk Lai Jaat Kong @ Lai Foot Kong as a Director of the Company who retired pursuant to Section 129 of the Companies Act, 1965 and to hold office until the next Annual General Meeting.

6. ORDINARY RESOLUTION 5

- **Re-appointment of Haji Mohd. Sharif bin Haji Yusof, who retires pursuant to Section 129 of the Companies Act, 1965 as a Director of the Company and whom shall continue to serve as an Independent Non-executive Director of the Company notwithstanding that he has exceeded a cumulative term of 9 years as a Director of the Company**

At the proposal of Mdm. Laura Lim Phaik Kuan and seconded by Ms. Crissy Lee Pooi Ling, the above resolution was put to vote by show of hands. The members present resolved to approve the re-appointment of Haji Mohd. Sharif bin Haji Yusof as a Director of the Company who retired pursuant to Section 129 of the Companies Act, 1965 to hold office until the next Annual General Meeting and to retain him as an Independent Director.

7. ORDINARY RESOLUTION 6

- **Re-election of Mr. Chan Soo Har @ Chan Kay Chong, who retires in accordance with Article 91(3) of the Company's Articles of Association as a Director of the Company**

At the proposal of Tuan Haji Ir. Abdullah bin Yusof and seconded by Ms. Low Ooi Wah, the above resolution was put to vote by show of hands and the members present unanimously resolved to approve the re-election of Mr. Chan Soo Har @ Chan Kay Chong as a Director of the Company who retired in accordance with Article 91(3) of the Company's Articles of Association.

8. ORDINARY RESOLUTION 7

- **Re-election of Mdm. Lai Man Moi, who retires in accordance with Article 91(3) of the Company's Articles of Association as a Director of the Company**

At the proposal of Ms. Crissy Lee Pooi Ling and seconded by Mr. Boo Kim Kee, the above resolution was put to vote by show of hands and the members present unanimously resolved to approve the re-election of Mdm. Lai Man Moi as a Director of the Company who retired in accordance with Article 91(3) of the Company's Articles of Association.

9. ORDINARY RESOLUTION 8

- **Re-election of Mr. Lai Voon Hon, who retires in accordance with Article 91(3) of the Company's Articles of Association as a Director of the Company**

At the proposal of Mr. Tee Cheong Yoke and seconded by Mdm. Laura Lim Phaik Kuan, the above resolution was put to vote by show of hands and the members present unanimously resolved to approve the re-election of Mr. Lai Voon Hon as a Director of the Company who retired in accordance with Article 91(3) of the Company's Articles of Association.

10. ORDINARY RESOLUTION 9

- **Re-election of Mr. Tan Thiam Chai, who retires in accordance with Article 98 of the Company's Articles of Association as a Director of the Company**

At the proposal of Mr. Lau Yew Mun and seconded by Mr. Thomas Wong Yoke Luen, the above resolution was put to vote by show of hands and the members present unanimously resolved to approve the re-election of Mr. Tan Thiam Chai as a Director of the Company who retired in accordance with Article 98 of the Company's Articles of Association.

11. ORDINARY RESOLUTION 10

- **Re-election of Mr. Hoe Kah Soon, who retires in accordance with Article 98 of the Company's Articles of Association as a Director of the Company**

At the proposal of Mr. Tee Cheong Yoke and seconded by Mr. Hoh But Kien @ Ho Pat Kin, the above resolution was put to vote by show of hands and the members present unanimously resolved to approve the re-election of Mr. Hoe Kah Soon as a Director of the Company who retired in accordance with Article 98 of the Company's Articles of Association.

12. ORDINARY RESOLUTION 11

- **Re-election of Dato' Azmi bin Abdullah, who retires in accordance with Article 98 of the Company's Articles of Association as a Director of the Company**

At the proposal of Mdm. Laura Lim Paik Kuan and seconded by Mr. Tee Cheong Yoke, the above resolution was put to vote by show of hands and the members present unanimously resolved to approve the re-election of Dato' Azmi bin Abdullah as a Director of the Company who retired in accordance with Article 98 of the Company's Articles of Association.

13. ORDINARY RESOLUTION 12

- **Re-appointment of Messrs. Raja Salleh, Lim & Co. as Auditors of the Company**

At the proposal of Mr. Boo Kim Kee and seconded by Ms. Crissy Lee Pooi Ling, the resolution in respect of the re-appointment of Messrs. Raja Salleh, Lim & Co. as Auditors of the Company was put to vote by show of hands. It was unanimously resolved that Messrs. Raja Salleh, Lim & Co. be re-appointed as Auditors of the Company to hold office until the conclusion of the next Annual General Meeting of the Company at a remuneration to be fixed by the Directors.

14. ORDINARY RESOLUTION 13

- **Proposed Renewal of Authority to Issue and Allot Shares pursuant to Section 132D of the Companies Act, 1965**

At the proposal of Mr. Tee Cheong Yoke and seconded by Mr. Lau Yew Mun, the following resolution was put to vote by show of hands and was unanimously approved by the shareholders:-

“**THAT** pursuant to Section 132D of the Companies Act, 1965, the Directors be and are hereby empowered to issue and allot shares in the Company at any time and upon such terms and conditions and for such purposes as the Directors may, in their absolute discretion deem fit, provided that the aggregate number of shares issued pursuant to this resolution does not exceed 10% of the issued share capital of the Company for the time being and **THAT** the Directors be and are hereby empowered to obtain the approval for the listing of and quotation for the additional shares so issued on the Bursa Malaysia Securities Berhad and **THAT** such authority shall continue in force until the conclusion of the next Annual General Meeting of the Company.”

15. ORDINARY RESOLUTION 14

- Proposed Renewal of General Mandate for Recurrent Related Party Transactions

At the proposal of Mr. Boo Kim Kee and seconded by Ms. Crissy Lee Pooi Ling, the following resolution was put to vote by show of hands and declared carried unanimously:-

“**THAT** approval be and is hereby given to the Directors to enter into and give effect to specified recurrent transactions of a revenue or trading nature with specified classes of Related Parties (as set out in Section 2.2.2 of the Circular to Shareholders dated 28 August 2015) which are necessary for the Group’s day-to-day operations in the ordinary course of business on terms not more favourable to the Related Parties than those generally available to the public and not detrimental to minority shareholders of the Company (“Proposed General Mandate”) and such approval shall continue to be in force until:

- (a) the conclusion of the next annual general meeting of the Company following the general meeting at which such Mandate was passed, at which time it will lapse, unless by a resolution passed at the meeting, the authority is renewed;
- (b) the expiration of the period within which the next annual general meeting is required to be held pursuant to Section 143(1) of the Companies Act, 1965 (but shall not extend to such extension as may be allowed pursuant to Section 143(2) of the Companies Act, 1965); or
- (c) revoked or varied by resolution passed by the shareholders in general meeting,

whichever is the earlier, and that for the avoidance of doubt, all such transactions entered into by the Company prior to the date of this resolution be and are hereby approved and ratified.

AND THAT the Directors of the Company be authorised to complete and do all such acts and things (including executing all such documents as may be required) as they may consider expedient or necessary to give effect to the Proposed General Mandate.”

16. ORDINARY RESOLUTION 15

- Proposed Renewal of Share Buy-Back Authority

At the proposal of Mr. Tee Cheong Yoke and seconded by Mr. Boo Kim Kee, the following resolution was put to vote by show of hands and declared carried unanimously:-

16. ORDINARY RESOLUTION 15 (Cont'd)

- Proposed Renewal of Share Buy-Back Authority (Cont'd)

“**THAT**, subject to the Companies Act, 1965, Bursa Malaysia Securities Berhad’s Main Market Listing Requirements, the Company’s Articles of Association and approvals of other relevant authorities, the Company be and is hereby authorised to purchase and hold such number of ordinary shares of RM1.00 each in the Company (“Proposed Share Buy-Back”) as may be determined by the Directors of the Company from time to time through Bursa Malaysia Securities Berhad upon such terms and conditions as the Directors may deem fit in the interest of the Company provided that the aggregate number of shares purchased pursuant to this resolution does not exceed 10% of the issued and paid-up share capital of the Company and the amount allocated shall not exceed the retained profits and share premium account of the Company.

THAT such authority shall commence immediately upon passing of this ordinary resolution until the conclusion of the next Annual General Meeting of the Company unless earlier revoked or varied by ordinary resolution of shareholders of the Company in a general meeting or upon the expiration of the period within which the next Annual General Meeting is required by law to be held, whichever occurs earlier.

THAT the Directors be and are hereby authorised to take all steps necessary to implement, finalise and to give full effect to the Proposed Share Buy-Back **AND THAT** further authority be and is hereby given to the Directors to decide in their discretion to retain the shares purchased as treasury shares or cancel the shares or retain part of the shares so purchased as treasury shares and cancel the remainder and to deal with the shares so purchased in such other manner as may be permitted by the relevant legislations and regulations.”
