NOTES TO THE QUARTERLY RESULTS

A1 Basis of Preparation

The unaudited interim financial report has been prepared in accordance with FRS 134: Interim Financial Reporting and Chapter 9 Appendix 9B of the Listing Requirements of the Bursa Malaysia Securities Berhad.

The unaudited interim financial report should be read in conjunction with the audited financial statements for the year ended 31 March 2010. The explanatory notes attached to the unaudited interim financial report provide explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the financial year ended 31 March 2010.

A2 Changes in Accounting Policies

The significant accounting policies adopted are consistent with those of the audited financial statements for the financial year ended 31 March 2010, except for the adoption of the following new and revised Financial Reporting Standards (FRSs), amendments to FRSs and IC Interpretations as described below, which are relevant to the Group's operations with effect from 1 January 2010:-

(i) FRS 101 – Presentation of Financial Statements (Revised)

Prior to 1 January 2010, the components of a set financial statements consisted of a balance sheet, income statement, statement of changes in equity, cash flow statement and notes to the financial statements.

Upon the adoption of the revised FRS101, a set of financial statements shall now comprise a statement of financial position, statement of comprehensive income, statement of changes in equity, statement of cash flows and notes to the financial statements. The statement of comprehensive income consists of profit or loss for the period and other comprehensive income. All non-owner changes in equity previously presented in the consolidated statement of changes in equity are now presented in the statement of comprehensive income as components in other comprehensive income.

The adoption of other new and revised FRSs, IC Interpretations and amendments to FRSs, and IC Interpretations has no financial impact on the current financial statements or consolidated financial statements of the previous financial year.

A3 Audit Report

The auditors' report on the financial statements for the financial year ended 31 March 2010 was not subject to any qualification.

A4 Seasonality or Cyclicality of Operations

The Group's business operations are not materially affected by seasonal or cyclical factors for the financial period ended 31 March 2011.

(i) The subscription by ASPL M9 Limited ("ASPL"), a wholly-owned subsidiary of Aseana Properties Limited, of 700,000 new ordinary shares of RM1.00 each at par in Urban DNA Sdn Bhd (formerly World Trade Frontier Sdn Bhd) on 20 April 2010, representing a shareholding interest of 70% of Urban DNA's enlarged share capital, for a total subscription amount of RM700,000 to be satisfied entirely in cash. This resulted in Urban DNA ceasing to be a subsidiary of the Company and accounted as an associate from the said date.

B1 Review of Performance

For the financial year ended 31 March 2011, the Group has achieved revenue of RM444.504 million as compared to RM393.076 million for the preceding year. This is mainly due to higher volume of construction works being completed during the year.

For the financial year ended 31 March 2011, the Group recorded an operation loss of RM0.638 million, before accounting for the share of loss in Aseana Properties Limited ("ASPL") (a 23.02% associate of Ireka) of RM7.697 million (2010: RM2.914 million) and a mark-to-market loss for share investment in Kinh Bac City Development Shareholding Corporation ("KBC") of RM2.698 million (2010: RM Nil). ASPL has announced that its results for financial year 2010 were mainly due to losses incurred on the disposal of its 1 Mont' Kiara retail mall and office tower and marketing expenses.

After including the two above items, the pre-tax loss is RM11.033 million, as compared to a pre-tax profit of RM9.199 million in the preceding year. The current year's results were also affected by lower construction margins due to higher costs associated with delays in the completion of a significant construction project. The project has a tight construction schedule and was hampered by labour shortages, adverse weather conditions and a couple of incidents on site.

B2 Material Change in the Quarterly Results Compared to the Results of Immediate Preceding Quarter

The Group has recorded a higher revenue of RM135.695 million in the fourth quarter of financial year ended 31 March 2011, compared with RM104.599 million in the preceding quarter; and a post-tax loss of RM0.937 million compared to post-tax profit of RM0.820 million in the last quarter. During the quarter, the loss of RM0.937 million was mainly attributable to mark-to-market loss for share investment in KBC.

B3 Prospects for the Current Financial Year

On the construction front, basing on existing works on hand, the Board expects turnover to be maintained in the current financial year. As at end April 2011, the Group's order book stood at about RM1.14 billion, of which about RM470 million remained outstanding. Over the last 12 months, the Group has tendered for jobs totalling over RM1 billion and has successfully secured three projects with total contract sum of about RM400 million. The Group has intensified its efforts to replenish its order book over the course of the year, in an increasingly competitive market. The Group expects prices of construction materials to increase and the labour situation to remain tight, but will endeavour to maintain the profitability of its on-going construction projects.

On the property development front, the current global economic crisis has affected the performance of real estate markets in Malaysia and Vietnam. The Directors would continue to be cautious in its business approach.

B4 Profit Forecast

The Group did not issue any profit forecast for the financial year ended 31 March 2011.

During the quarter under review, the Company has disposed off 250,000 number of shares in KBC at an average net price of about VND 32,593 per share. As at 31 March 2011, the Company held 1,046,750 ordinary shares in KBC.

Save for the aforesaid, there were no other purchases, disposal or investment of quoted securities for the current quarter and financial period-to-date.
